GridInterop 2013

Ron Melton, GWAC Administrator

Ron Melton shared that there is not a budget for PNNL to support GridInterop planning as in the past years. There is a great deal of project management that needs to take place in order to have a successful event and if the Council chooses to move forward with the event, the Council would need to commit to plan the event by volunteering their services and time.

A few positive reasons to move forward with the event include the need to receive comments from the industry and smart grid community on the Transactive Energy Framework that will be unveiled at the May Transactive Energy Conference. Also, several people have expressed interest in presenting their transactive energy related work at the conference, but their work didn't fit into the specific focus of the Portland conference, but could be part of a later meeting as the Council continues to socialize the framework document.

A possible issue for holding GridInterop would be the timing. Is the event too soon after the May Transactive Energy conference to have value and does the Council have enough time and energy to organize the meeting while also finishing the required completed draft of the Transactive Energy Framework?

Discussion continued on the involvement with SGIP and if NIST has any interest in participating Grid-Interop 2013.

Action item was captured for Council to email their thoughts and ideas regarding the possibility of holding GridInterop 2013 to Ron Melton and Mark Knight.
