



Lorenzo asked about the vision, "What is achievable, believable, and acceptable?" If we are going into unknown territory isn't this subjective?


Ron A. said the original talk was a bit subjective in this same respect, but this is our starting point. They have derived some consensus on future vision.

She explained that the material works nicely for large organizations that are working on energy efficiency or decarbonization planning

and tracking. The presentation's key point is the importance of data management as it relates to data heavy policies like performance standards and decarbonization programming.

The goal of the software is to move away from spreadsheets to easy-to-use data tools that can handle the complexity of building performance standards. We will look at a high-level version of the tools.

All of the tools we will look at are free and most are open source.





Marc Costa thanked Sydney and said this subject is something that he appreciates. He is familiar with the precursors of SEEDS as well.

He said his organization used to have a contract where they worked with muni's and utilities and there were climate action plans or building performance standards. This data collection that she showed is so valuable to visualization and decarbonization efforts as we design the system architecture of the future, and the IRP process.

Marc added that as people adopt this information, he is interested in the feedback that she is getting. He asked about the future of buildings stock.

Sidney said that right now as they are centralizing this data for use, they haven't started to get much feedback yet. She said one component that people are looking at is using the collection within SEED which buildings should be getting additional financial assistance to comply with.

Marc said the ASSETS forms put out 8760's...and it's so valuable such as with load profiles and NREL's residential and commercial stock. It's foundational work that could change the way we do things on this side of things.

Larisa Dobriansky said looking to the future, she is happy to see this evolution and she is familiar with efforts such as the work at LBNL that Marc referred to. She asked how Sidney sees all of what has been done with energy efficient buildings and what is being fed in? How do we encourage more data standardization access?


Sydney said she thinks the work is a potential use case. The work is a bit siloed at the moment from their work with jurisdictions and building performance standards. As this continues to evolve and as adoption outside of the building performance standard world increases, there would be a great opportunity for using the software.

Kay Aikin said benchmarking is wonderful – she spoke with a sustainability director in Portland Maine about this recently; If property owners will submit the data and if it's streamlined, that will help, they are trying to get the data into the platforms. Kay noted that if you could do it with one button that would be ideal. Kay gave the example of Green Button; a way to get all your electric data streamlined - implemented by asset owners. Kay added that Chris Irwin has talked about it. If it's easy you would get good data. Kay mentioned Jeremy from Green Button. Sydney would like to follow up with Jeremy.

Sydney confirmed there is an effort underway to simplify and remove barriers and make things a lot easier. She said that various jurisdictions and the EPA are talking about simplifying the benchmark process for building owners as well as for submission and data collection.







Ron Melton said he has some doubts about the "symposium" suggestion and thought it sounded like a GridWise Alliance event. He also mentioned the original interoperability meetings.


Ron A: What about a main title name and a topical subtitle?


Ron M. said he thinks a topic can be helpful, he gave the example of ISGT.

SaLisa Berrien joined the meeting and was introduced by Ron Ambrosio. Ron had met her recently at an engineering meeting in Tampa, Florida where she was a keynote speaker.

SaLisa introduced herself and said she is the founder and CEO of COI Energy – they focus on recycling energy capacity and then enabling it to be exchanged as excess energy exchanged, as a peer-to-peer exchange where businesses are able to sell that excess capacity to other businesses selling capacity. It helps the reliability and resiliency of the grid and reduces the carbon footprint of the businesses and helps support energy equity because every business on our platform will pay a portion of their savings to marginalized communities or LMI communities to ensure that they will have affordable access to clean energy resources which shows up as energy efficiency upgrades like for electrification, community, solar weatherization, and those types of services.

Jaime asked about the scale of capacity.

They are working with commercial businesses but not industrial right now. They are helping businesses to minimize their peak demand to their base load operations down to that delta and that is what they

are selling on the exchange. The range could be 250 kilowatts of peak demand all the way to 10 to 30 megawatts. They don't limit the size of the customer.

Jeff Morris had no NARUC updates today.


Jaime suggested adding INCOSE to Liaisons. Ron Ambrosio said he approved of that suggestion; he is familiar with that group.
